Terms and Conditions

Contract

The Contract for a gym membership shall be made between the Client and Saltmarsh Spa and Fitness. The Contract will be governed by UK Law. It will be entered into when the first month's payment is processed. The Contract will be subject to all the following conditions and it is the client's responsibility to see that all rules are adhered to.

Payment Terms

The first month's payment will be taken on induction plus a £25 administration fee. An agreement is then entered into and each month the payment will be taken via GoCardless. Members must sign up to GoCardless within 4 weeks of their induction or their membership will be cancelled. If the contract is cancelled one month's notice must be given. If at any time during the membership payment becomes overdue by six weeks or more, the membership will be cancelled with immediate effect.

Loss of Entry Card

Replacement cards will be issued for a charge of £10.

Lockers

Lockers can be hired for £1 per week which will be added to your monthly membership fee. Please only store dry equipment and clothing in the lockers. Padlocks will need to be purchased separately. If you have not hired a locker, you may use them when using the gym and Spa. Please remove all your belongings from the locker when you leave.

Spa

For your Health and safety, the Spa is closed every Monday for Cleaning. Please do not use the Hot tub or steam room whilst this area is being cleaned.

Cancellations

Creeksea Place Barns must be informed of any cancellations for whatever reason in writing by the client named on the membership form. The effective date of cancellation will be the date that the written instructions are received by Saltmarsh Spa and Fitness. One months notice must be given.

Care of the Gym

The Client shall in all matters concerning the Property deal with the Owner. The Client shall take all reasonable and proper care of the gym and its surroundings. The client will leave them in the same state of repair and in the same clean and tidy condition that they were found in. The Client will inform Saltmarsh Spa and Fitness immediately of any damages and breakages for which they have been responsible. The Client is legally bound to reimburse Saltmarsh Spa and Fitness for replacement, repair or extra cleaning costs on demand.

General Responsibilities of the Client

- To not smoke inside any areas of the gym.
- To maintain the security of the gym i.e. to take responsibility for the closing the doors as requested.
- To not leave child members aged under 16 unattended at the gym

Health and Safety

This is an unmanned gym and all equipment will be used at the member's own risk. All equipment must be used in accordance with the manufacturer's instructions. Appropriate gym clothing and footwear must be worn at all times. It is unadvisable for pregnant women or members with heart conditions to use the spa area at any time.

Named Member

Only the member named on the membership card must use it to gain entry to the gym. Saltmarsh Spa and Fitness reserves the right to cancel the membership at any time if this condition is not observed.

Liability

The Owner will not accept any responsibility for the personal belongings of the members or the members' vehicles and it is the responsibility of the member to arrange appropriate insurance cover in respect of these items.

Termination of Membership

The right is reserved to terminate the membership with immediate effect if the member fails to observe the regulations and requirements listed in these terms and conditions. In the event of termination under the provisions of

this clause the member will not be entitled to any refund of their membership fee.

The Owner reserves the right to alter and amend or add to these terms and conditions at any time.
